<b>UNIFORMS</b>	The participants of the championship will be provided in uniform by the organizers (uniforms according to the layout of CEV)
<b>TRANSPORT</b>	<p>Players, Team Managers, Coaches, Physiotherapists, NF members, etc. are responsible for their own international and domestic airfare and for any further expenses such as visa or airport taxes. For Neutral Referees, nominated by EEVZA, International travel expenses will be covered by EEVZA.</p>
<b>LOCAL TRANSPORT</b>	<p>Local Transportation for the players, coaches and etc., as for the accompanying persons is under their own responsibility. If players and coaches choose a hotel offered by the Armenian Volleyball Federation, then the organizer will arrange a transfer. Transportation of Neutral Referees is organizers responsibility</p>
